ISU Acacians earn \$3,000 in Scholarships for Academic Excellence

Academic success for the undergraduate members of our chapter was rewarded when ten Brothers each received a \$100 scholarship from the Corporate Board. Our undergraduate Brothers who earned this scholarship include **David Frost, Martin Gran, Greg Janda, Keegan Kautzky, Trenton Norman, Michael O' Doherty, Jeff Peil, Tristan Pritchard-Meaker, Nathan Russell and Michael Wooley**. The Corporate Board awarded these scholarships from our **ACACIA Undergraduate Scholarship** which we set up through the ISU Foundation many years ago.

In addition, three Brothers also received scholarships from the **Acacia Fraternity Foundation**. These three Brothers and the amount that they received are **Michael O'Dohoerty** (\$1,000), **David Frost** (\$500), and **Keegan Kautzky** (\$500).

There are currently four funds from which the Corporate Board may award scholarships. These funds and their current balances are as follows:

Acacia Leadership Scholarship	\$ 2,017.64
Acacia Undergraduate Scholarship	\$ 3,246.22
Acacia Graduate Scholarship	\$ 2.24
ISU Chapter Fund – Acacia Foundation	\$ 3,760.50

As you are aware, the cost of a university education has been increasing for many years. These funds are used to reward our Brothers for their hard work and achievement in their academic pursuits. They are also a valuable rush tool which demonstrates the tangible support which our Fraternity and its alumni provide to the undergraduate Brothers of our Fraternity.

Updated Corporate Board Constitution and By-Laws to be voted on at VEISHEA Alumni Meeting

At the Homecoming board meeting, the Board completed its review of a proposed new set of articles of re-incorporation and by-laws. The current articles and by-laws contained a number of items which were in conflict with the Laws of Acacia, and referenced a number of procedures which are otherwise no longer valid as well.

We believe that this set of documents will enable us to continue the work of the Board and the Chapter in a more efficient and effective manner to serve the needs of both our alumni and the active members of the Fraternity.

Significant among these changes is a redistribution of duties within the Board. These changes reflect the fact that we now have an active chapter at the Iowa State campus, which we did not have in 1997 when our documents were last revised. We have modified the duties so that they more accurately reflect the

needs of the Board and chapter at this time. This also allows us to more evenly distribute the various duties among the board members while allowing for more active participation from our alumni.

ISU ACACIA Alumni Contribute \$565.00 to 2003 Scholarship Fund Drive

In the last newsletter, we reported on how a sprinkler was placed on the front porch of our Fraternity House and the damage that the water caused to the basement area below. Restoration efforts have been completed and the basement is once again a fully functional area for the men to use as a study and relaxation area.

In a generous show of support for our problem, the **Grand Lodge of Iowa, A.F. & A.M.** presented us with a check in the amount of \$1,000 to help towards the costs of the repairs. When we had our rechartering celebration in October, 2001, we were fortunate to have Brother Wiliam Crawford of the Iowa Grand Lodge attended and speak at our celebration.

The scholastic results of the house and these scholarships are our tangible proof to many skeptical parents that our Fraternity is serious about academics, and that we are not simply the stereotypical “Animal House” of movie fame.
