Pledge Class is #1 for third consecutive year with a 3.16 G.P.A.

The Spring, 2005 semester grade results are in, and Acacia continues to lay claim to the top academic honors in the Iowa State Greek System. The results for the top five chapters were as follows:

My gracious! What a generous thing for Brother Drdla to do.

I noted you had offered only two basic alternatives – money market or mutual fund – for an endowed fund. I am not up to date on the subject, as you no doubt are, but I wondered whether the funds could not be invested in U.S. Treasury Bonds, which would yield less than the 6.5% mentioned for mutual funds but would safeguard the principal amounts. Because interest rates are rising at this time, perhaps investing

in T-bills fo Treasuries with short maturity dates would be an option.

I offer this suggestion not knowing whether a 501(c)3 corporation can do this at this point. I know that years ago when our church had the proceeds from a bond issue on hand and did not need the total amount to cover current construction costs our church treasurer did invest the uncommitted funds in T-bills and, over the life of the construction project, earned a tidy return that was given to a start-up congregation as seed money for their building fund. The T-bills, beging short-term (90-days?) instruments, were convenient in that they matured as funds were needed for construction progress payments. I have not checked, but I believe that T-bills are currently earning somewhere around 3%.

Like you, I am grateful to Brother Drdla for his generosity.

Board Votes to Establish the Edwin Drdla Educational Endowment Fund

In the last newsletter we reported on the fact that Brother Edwin Drdla - #377 had bequeathed a significant amount of money to the Board through the Acacia Fraternity Foundation. We requested input from the alumni on what should be done with these funds, and many of you replied with suggestions that literally ranged from investing all of it the expendable account to placing all of it in an endowed account.

A special committee of the Board (Chip Riedmann, Jeremy Davis and John Kvinge) was appointed to develop a proposal for consideration by the Board for the use of these funds. As was reported in the last issue of the newsletter, the Board had a number of options for the use of these funds.

After considerable discussion, the Board voted to split the \$200,000 in funds that we have received so far by placing

\$40,000 in the chapter account (an expendable account) and \$160,000 in the endowed fund (in which only the interest may be used).

We will be receiving a second payment from the estate in the near future. We don’t know when that will occur as the accountant handling the estate is waiting for a final letter of approval from the Internal Revenue Service. Once that happens, we will receive the balance of the amount allocated to us from the estate. All of the funds from the second payment will be placed in the endowed account once they are received.

We would like to thank all of the alumni who provided us with input on how to invest these funds, and we hope that you will support our decision on the use and investment of these funds.
