Brother George Gross - #343 to Write Book on the History of the Iowa State Chapter

There is a major project in the works, and it is centered on compiling a history of the Iowa State Chapter of Acacia Fraternity. This project got started based on a series of e-mails between Brother's Gross and Zarr. After much discussion, they agreed to split this project into two parts with both of them gathering as much information as they could about a variety of topics related to the history of the chapter. Brother Gross agreed to take on the task of gathering information for the period from 1930 – 1969. Brother Zarr will be responsible for gathering information from 1970 – 2009.

At this point, Brother Gross has compiled a “working document” that is about 65 pages in length. We expect the final document to be around 150 to 200 pages in length. At this point, we have not included any pictures in the working document (as we don't have any yet), but our hope is that we can fill it with lots of pictures, each one tied to its relevant decade. We will also do our best to recognize each person who has contributed a picture or story with the book.

The general format of this book is that it is going to be laid-out in terms of “decades.” Thus, we will “group” the Brothers in the house based on the date of their initiation into the Fraternity. Our decades will start with the 1930's, and continue on to the present time. One of our original intentions with this book is to try and correlate the events of the times with changes and events that occurred at the chapter. For example, our first chapter will concern the struggles of the chapter to survive during the years of Great Depression in the 1930's.

Historical information is available on the college and society, but what we are really looking for is remembrances from members who lived in the house during those years in terms of what they needed to do to keep the house going. We also are especially interested in the anecdotal events that occurred. Specially, what funny (pledge skip events, practical jokes), unusual (I will leave this up to you), noteworthy (intramural victories, Greek events), heartwarming (how did you meet your future wife), or even sad events occurred that the Brothers from that time would like to have remembered in this

book. We want this book to be “alive” with pictures and words from the members who were there at the time.

Please keep in mind that these criteria apply to **all** of the decades. I also want to point out that we are also equally interested in topics that might be considered to be more “mundane.” For example, how were meals served, what were the living accommodations like, what were the typical daily responsibilities of the Brothers living in the house? What was it like to be a pledge in the 1940's, so that we can contrast that with other times? Were you in the military or ROTC? What will enable this book “come alive” is not a recitation of names and dates, but the reporting on what it was like to live from day-to-day in the chapter house with your peers. We are hoping that both those who were officers and those who were members will equally send in their stories to be told.

We would also like to know what kinds of struggles you had to endure in order to stay in school. Did you have a job, did you receive a scholarship, and did you have to borrow money? As you can see, there are a wide variety of topics that can and we hope will be addressed in the writing of this book.

But most important of all, this book is an opportunity for you to provide a lasting record of your memories and to bring alive the days in which you lived in the fraternity. To a certain sense, it is an opportunity for you to “immortalize” your memories so that they can be passed on new generations of Brothers who can then fully appreciate the heritage and legacy that they are receiving when they join the ranks of Acacians.

We have access to lots of demographic data about the college and its students. We also have lots of demographic data about society during these 100 years. Dry statistics abound, but what we really need from you, are the following:

1. photographs that you will share with us to be reprinted in this book
2. your personal memories that you will agree to share and be printed in the book

There are also a number of things which have disappeared over the years which we would like to find. For example, we have only just a few songs of Acacia that we have available to us. However, I remember that as a pledge, we would sing songs on Saturday evenings that were not found in the “official” Acacia songbook. If anyone has copies of these songs, we would love to get a copy of them back from one of our alumni. (Not that we would necessarily print them in this book!)

Items such as this have tremendous historical value to us, and we want to include as many such items as possible in this book. To do this we are going to need your help.

One of our first tasks is to collect as many pictures as possible from all of the years. It is not necessary that we receive original photographs unless you wish to send one. The preferred method (so that nothing gets lost that cannot be replaced) is to send a copy of a photograph to Brother Gross via e-mail. The photograph can be in a “.jpg” format so that

we can download the photograph and identify the sender and topic and year in its file name. If you want to send an original you may, and we will make every effort to scan it into our database and then return it to you.

The second item that we need is your stories. Again, these can be sent via e-mail as attachments to the e-mail or included as a part of the original e-mail message itself which we will then download and “cut and paste” as necessary.

A clear sign of the increased competition that now exists for academic excellence in the ISU Greek System is demonstrated in these results as three of the five chapters listed in the top five were new to the list in this semester. Only Acacia and Pi Kappa Phi were listed in the top five academic chapters for the Fall, 2006 semester. Our chapter has focused on attracting the best and brightest young men, and over the past few years these results have paid consistent dividends, with Acacia placing either #1 or #2 every semester since we returned as members of the ISU Greek System. The primary goal of the members of the chapter is now to return Acacia to sole possession of the #1 academic spot.

Chapter House Improvements Continue in 2007

Improvements to the chapter and property grounds continue to move forward. This summer, three major projects were completed that will improve the quality and safety of the chapter house and its property.

The first project involved building an enclosed entrance to the east door on one of our two basement apartments. Many of our alumni (me included) will remember that this is where the kitchen was located when they lived in the house. Today, it is a kitchen/dining room area for the three-room apartment in the basement.

The basement apartments typically goes to upperclassmen based on their service to the active chapter under a "point system" developed and followed by the undergraduate chapter. These improvements were completed to bring the facility up to code requirements for the City of Ames.

A new floor was also installed in this kitchen area. The bathroom was completely remodeled with a new shower and floor installed. The outside entrance was built with brick to match the existing exterior of the house. A new door was

installed, along with an area for plantings (again to meet city code requirements). This enclosed entrance will also ensure that rain and snow runoff won't be able to drain into the basement area and potentially damage the carpet in the bedroom or linoleum flooring in the kitchen. The total cost for all of this work was approximately \$15,000.

We also installed a new fence around our outside storage shed (again, to meet code requirements) and moved the shed in order to provide more useable space for parking on the east side of the property. Brothers **Nicholas Siebold - #1032**, **Jared Ramthun - #1019**, **Michael Webber - #1038**, **Jeremy Davis - #969**, and **Harold Zarr - #814** worked on this project

and managed to complete it in just a few hours one Sunday morning prior to the start of fall semester classes.

One other project was also completed by **Michael Webber - #1038** and his brother who owns a landscaping business in Ames. They removed the old railroad tie steps on the south side of the property and replaced them with limestone block steps. These steps look great, and should last for many, many years to come.

Our thanks to all of these Brothers for their work on improving the chapter house and property!

ISU Acacians receive \$6,100 in Scholarships from Acacia Fraternity Foundation
