Acacia is tied for #1 in ISU Greek System with 3.29 G.P.A.

The **Spring, 2009** semester grade results are in, and **Acacia Fraternity** was tied for the #1 academic spot in the Iowa State Greek System by an old nemesis, FarmHouse. The results for the top five chapters are as follows:

Competition for the top academic slot has become more intense as time has gone by as many potential members, and their parents, use academic performance as a key criteria in deciding which fraternity to join. New members and their parents are concerned that the living environment will be one in which academic excellence will be supported and encouraged. The academic record of Acacia has been a key factor in our success in attracting only those members with truly exceptional academic potential.

Academic excellence is a hallmark of the members of Acacia Fraternity. **As you can see from the table on this page, our chapter has been ranked #1 for ten out of the past eleven semesters!** Since the chapter was refounded in 1999, Acacia has held the #1 academic slot more than 60% of the time, and we have held either the #1 or #2 academic slot 95% of the time. An impressive record of achievement by any measure.

Our focus remains on recruiting only **exceptional men** who are **dedicated to their academic studies** and to making a **positive contribution to society**. This has been a core strategy which has been shown to be successful over the years. It is our focus on academics, personality, and a demonstrated level of leadership which has enabled us to build the preeminent academic Fraternity at Iowa State.

Based on the results for the spring semester, a total of **\$3,400** in scholarships for academic excellence was awarded to our Brothers in the active chapter. Board Approves Significant Property Improvement Projects

Each summer, the Corporate Board reviews the financial results for the previous fiscal year and adopts a budget for the next fiscal year. The Board maintains four different accounts at our bank – a checking account and three money market accounts designated for specific projects related to the chapter house. Two of the money market accounts are used for projects directly related to the chapter house and the third is used for automatic payments on the mortgage on the chapter house.

At the summer Board meeting held on June 28, 2009, the Board approved a number of capital improvement projects for the next fiscal year.

The **first project** that was approved consists of **two landscaping upgrades** designed to address problems related to the outside appearance of the property. These two projects will cost approximately \$6,000. The first upgrade will be the construction of a sidewalk along the south side of the chapter house leading from the sidewalk to the back of the parking lot on the east side next to the storage shed. This sidewalk will be a flag stone pathway lined with limestone edging.

The second landscaping project will install limestone edging along the flower beds on the west (front) side of the chapter house. Together, these two projects will significantly improve the immediate area around the front and south sides of the chapter house and give it a much more esthetically pleasing appearance. We would have liked to replace the sidewalk from the front of the house to the street and the area around the sign by the street, but we lacked the funds to cover this part of our overall landscape improvement design. We are hoping that we can accomplish the next phase of the landscaping project next summer.

The **second project** is the **replacement of the soffits** on the chapter house. Work was begun by one of our chapter members (Noah Gullikson) this summer to repaint them when we discovered that quite a bit of the wood was rotting due to age. We decided that the only feasible solution was to simply have all of them replaced and repainted. This project is scheduled to be completed in September.

The **third project** that will be completed is one that has talked about for many years (if not decades) and is seriously overdue. A contract for **tuck pointing of the entire exterior** has been signed and will be completed in October. This project will cost \$19,000 and will be funded out of the money that the Board has accumulated through rent and alumni donations over the past few years.

A number of the Alumni Boards of the Greek houses contracted to have their exterior brickwork tuck-pointed this

summer, so we were able to negotiate a lower cost due to all of this work that will be done this summer.

The **fourth project** will be either the **gutting and complete refinishing of the basement area** into a chapter meeting and recreation room, **OR** the **installation of a hard surface parking lot** on the north and east sides of the chapter house. Our original intent was to upgrade the basement next summer, but the Ames City Council recently passed a new ordinance that requires all non-paved driveways and/or parking lots in the city to be paved.

There are a surprisingly large number of individual family homes in the city that do not have paved driveways. If I remember correctly, it could be as high as 20% - 25% of the homes that do not have paved driveways. This ordinance would require **all** of them to have their driveways paved by the end of next summer.

As you might expect, the good citizens of Ames were not pleased when they heard the news of this new ordinance. With elections for the Ames City Council set for this fall, there is apparently a very strong movement in the city to vote out the existing members of council and vote in a new city council who will then repeal this ordinance which was just passed.

For our part, we have allocated \$30,000 from our capital improvements account to cover either the cost of the basement remodeling project or the new parking lot, but not both. We have no choice but to adopt a “wait-and-see” approach as to which project we can complete. Obviously, our preference would be to complete the makeover of the basement, but only time (and the election this fall) will tell.

While not exactly a “remodeling” project, the Board also voted to maintain our current mortgage payment amount for the next fiscal year. When we first set up our mortgage, it was designed as a variable rate note that “resets” the interest rate once every three years. The new rate will go into effect on August 1st, and we anticipate that the new rate should be significantly lower than the current rate. If this holds true, by maintaining our current payment, the Board estimates that we can cut an additional two or three years off of our principal mortgage balance prior to the next rate change. This would mean that we would only have to make payments for five or six years at most before our mortgage is completely paid off. Saving two or three year’s worth of payments (at approximately \$3,300 per month) would be a significant savings!

Active Chapter Keeps Busy with many Events!

An old saying goes, “All work and no play makes Jack a dull boy.” While the men of Acacia are serious about studying for their courses, they also believe in taking time out for recreation and in helping their fellow man as well.

On April 25th, members of the Iowa State Chapter of Acacia Brothers **Brandon Behrens** and **Austin Schlatter** man a display to bring awareness to the needs of the Youth and Shelter Services in Ames. Members of the chapter worked at both East and West Hy-Vee's and asked people to purchase extra items for Youth and Shelter Services in Ames, as part of Shelter Awareness Day. Hundreds of dollars of non-perishable food and personal items were donated by customers at these two stores for use by the patrons of the shelter. (A second photo is shown below.)

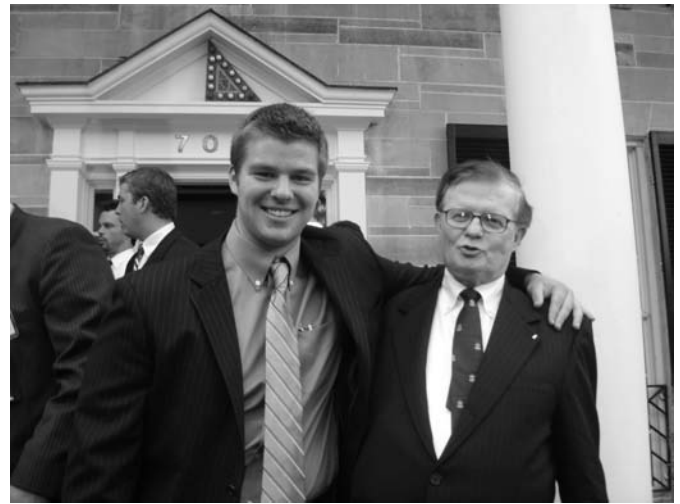

Acacia Leadership Academy Report ~ July 29 to August 2, 2009

Three undergraduate and three alumni brothers of the Iowa State Chapter of Acacia Fraternity attended the 8th Biennial Acacia Leadership Academy in Bloomington, Indiana from July 29 to August 2, 2009. Representing the undergraduate chapter were: **Michael Weber - #1038, Nic Seibold - #1032, and Matt Zylstra - #1061**. Representing the alumni were: **John Pugh - #442, James Schlick - #708, and Jeremy Davis - #969**. In total, 105 undergraduates, representing the chapters and colonies of Acacia Fraternity, participated in the ALA which was hosted at the Indiana Chapter of Acacia Fraternity house.

The Acacia Leadership Academy is considered to be the premier fraternal event. On the odd-numbered years (non-conclave), Acacia Brothers from across the country convene for a leadership conference that places the participants in a chapter-setting where all brothers live and operate as a fraternity chapter under one roof for the duration of the academy. From electing "chapter" officers to strengthening the ties of friendship, one with another; the Acacia Leadership Academy exists to put theory into practice for the undergraduate brothers who attend and teach them the skills they need to positively impact their home chapters.

During the course of the week, the undergraduate brothers attended a number of workshops which focused on membership recruitment, recognizing and eliminating hazing, Cornerstones, and personal financial management. Additionally, throughout the week, there were a number of “small group” sessions facilitated by alumni of Acacia Fraternity. During the small group discussions, brothers shared “best practices” for recruitment, membership education, and chapter operations. While not in workshops or small group discussions, the brothers participated in the Acacia Olympics, which included activities such as bowling, volleyball, acacia toss, horseshoes, euchre, 3 on 3 basketball, and darts; all in a round-robin style tournament where each small group section competed against another group. In an effort to emphasize teamwork and the art of working together, each small-group section also participated in a paintball event.

While the undergraduate brothers were participating in their various events, the Acacia Fraternity Foundation also met and conducted its annual meeting. Our chapter is very fortunate to have one of our alumni brothers, **John Pugh** - #442, serving as a Director. Additionally, Brother **Harold Zarr Jr.** - #814 also serves on the investment committee for the AFF. As can be expected, the Nation’s economy has impacted the AFF’s corpus negatively. It is with great hope that the financial sector will turn-around within the year. On Thursday evening, the AFF hosted a reception for Acacia Alumni who were able to attend. Brother **James Schlick** - #708 was in attendance, along with Brothers **John Pugh** - #442 and **Jeremy Davis** - #969.

A particular hi-light of the week was the initiation of a new brother from the Missouri Chapter. As part of the initiation process, each small-group section was assigned a particular degree of the initiation ritual. One of the goals of this process is to teach the attendees the proper way to exemplify the ritual. As is prescribed in the ritual, the initiation was completed at the Bloomington Masonic Lodge. On Saturday evening, the Acacia Leadership Academy concluded with a closing banquet where several undergraduate brothers were recognized with scholarships funded through the AFF. Of particular note, Brother **Michael Weber**, current Venerable Dean, was the recipient of the **George F. Patterson Scholarship** in the amount of \$3000 for his leadership in the chapter and on campus. At Iowa State, he currently is the Business Manager for VEISHEA and is also the Speaker of the Senate for the Government of the Student Body. The George F. Patterson, Jr. Scholarship is named for Brother Patterson who tirelessly worked for the betterment of Acacia Fraternity and truly is one of the Great Acacia brothers and an

individual brother who truly left a long-standing legacy for our fraternity.

Our one-hundred-two year-old house has recently benefited from a fire-suppressant sprinkler system and new windows around the house (replacing the inefficient single-paned windows). This summer the corporation board has undertaken the complete upgrade from a steam heating system to a modern hot water boiler system. We are also expanding and paving our back parking lot. All of this has been possible through the last two years of our chapter's Centennial Capital Campaign. To date we have received pledges amounting to \$236,000 out of a stated goal of \$345,000. As chairman of the campaign, I have been overwhelmed by the alumni support of the chapter. The active chapter has been equally supportive of the corporation's efforts, and they have contributed many thousand dollars on top of their annual rent towards the campaign.

Dear Brother Davis,

I completed reading the Iowa State Chapter history today. I am very pleased with the book, and I congratulate you and your co-authors on your laudable efforts. Researching and writing (and publishing) a chapter history is no easy feat, and the meticulous attention to detail shines through strongly in your mutual effort. I feel especially proud of the Iowa State Chapter and her efforts to recolonize and recharter after a period of years absent from the campus.

The alumni who have sustained Iowa State and Cornell Chapters share much in common. Harold Zarr '75 and Steve Stein '73 share a remarkable number of similarities. They have both served as corporation board presidents for an unprecedented period of time, both have contributed time and money to their chapters, and have both have been justly (if belatedly) recognized for their hard work through local and national awards (Order of Pythagoras and Award of Merit). Cornell Chapter has also benefited greatly from the life-long commitment by Jim Showacre '50. He may very well be the John Pugh or George Gross of Iowa State Chapter. Jim too has received national and local recognition. And I cannot deny the impact of recent alumni to local and national affairs.

The history of the Cornell Chapter parallels and intersects the history of the Iowa State Chapter in many important ways. We have shared connections through brothers. Brother Howard Pierce (Cornell) was a founding member of the Cornell Chapter, and he helped to found the Iowa State Chapter as well. Stewart Burger has been generous with his time and resources to both our chapters. But we also seemed to celebrate similar periods of excellence and experience unfortunate downturns concomitantly. Cornell Chapter did not officially recolonize, but we were reorganized in 1987-1988.

Jeremy, your efforts in refounding the chapter and sustaining its excellence are notable and praiseworthy. Congratulations on your many accolades and election to national office within the fraternity. The fraternity is in good hands. I have the enviable position of returning to Cornell University in the fall for graduate work in history, and I look forward to living in Ithaca and being a more active part of the fraternity again (in person).

We too benefited from outstanding leadership consultants and financial support from alumni and the Acacia Fraternity Foundation. Our two chapters have had a focus on academics, outstanding newsletters, and chapter programming. We have both been recognized as either outstanding or superior chapter by Acacia Fraternity in the last four years.

There is much more I could write about specific chapters, stories, or moments. I could also write critically (as an academic historian) about your interpretation of the past, composition and style of the prose, and inclusion of detail.

A memorial service was held on Sunday, September 7, 2008 in Edwards Church UCC, Framingham, for professor geology and geophysical David D. Roy, who died August 30, 2008 from Alzheimer's. He was 70 years old.

A native of Baton Rouge, Louisiana, Dr. Roy taught at Boston College for 33 years and served as chairman of the Geology and Geophysics Department for six years. One of Dr. Roy's professional accomplishments was his mapping of the geologic structure of northern Maine for his research dissertation, through which he was able to contribute to the State of Maine Geologic Map and become a licensed geologist in the state.

Dr. Roy would drive for hours to bring undergraduate and graduate students to remote sections of the state, which suited geologist's specialization in sedimentary rock.

Recognized as an exemplary field geologist, Dr. Roy was also a dedicated teacher, said colleague Prof. Chris Hepburn. "Dave was entire devoted to his students and vise versa," said Hepburn. "It was noted when he retired that he was probably the only faculty members who over 30-plus years never missed an office hour. That was sacred to him."

He is survived by his wife Marjorie, brother Arthur, and daughters Deborah, Margaret and Patricia.

**Virgil S. Lagomarcino - #574

Virgil Seth Lagomarcino of Ames, one of Iowa's leading educators in a career spanning more than four decades, passed away peacefully in his sleep Tuesday, July 21, 2009, with family members at his side. He was 88.

Virgil Lagomarcino was born March 23, 1921, in Plainfield, Iowa, the son of John James Lagomarcino and Cora Alice Scott Lagomarcino. He attended Waverly High School, graduating in 1939. He attended Coe College, Cedar Rapids, earning his B.A. in political science in 1943; Drake University, earning his M.S. in education administration in 1948; and Iowa State University, earning his Ph.D. in education in 1955. In 1944, he married Neva Dorothy Baird, also of Waverly, at the Little Brown Church in Nashua, and on July 29, 2008, they celebrated their 64th wedding anniversary.

Dr. Lagomarcino taught high school in Vinton in 1944-45 and served as superintendent of the Keystone Consolidated Schools from 1945 to 1949, and Anamosa Public Schools from 1949 to 1951. He became a regional consultant for the Iowa Department of Public Instruction in 1951, and a research associate at Iowa State College (now University) while attending graduate school. In 1954, while still a graduate student, he was named Director of Curriculum and Supervision and Director of Public Junior Colleges for the Iowa Department of Public Instruction. In 1955, he joined the faculty in education at Iowa State, advancing to the rank of professor; was appointed Director of Teacher Education at Iowa State in 1961; and, upon formation of the College of Education at Iowa State in 1968, was named its first dean, a position he held until his retirement in 1990. Upon his retirement, he was named Professor and Dean Emeritus.

As Dean of Education, Dr. Lagomarcino oversaw the development of the new college and, in the mid-1970s, the remodeling of the former Veterinary Medicine Quadrangle into a home for the College of Education and Department of Psychology. In 1986, that complex was named Virgil S. Lagomarcino Hall in recognition of his contributions to Iowa State and to education.

He is the author of several professional publications on decision making processes, bond elections, and teacher

preparation for Iowa school districts. He was a consultant to several colleges and universities, and an examiner for the North Central Association (NCA) Commission on Colleges and Universities, including serving as chair of numerous NCA accreditation teams. He was a member of two U.S. State Department educational missions to Egypt, and several education seminars in Europe.

In Iowa, Dr. Lagomarcino served as chair of the Governor's Task Force on Teacher Preparation/Participation and the Iowa Commission for the Study of Teacher Excellence; was charter president of the Iowa Association of Colleges for Teacher Education; a member of the Iowa Legislature Excellence in Education Study Committee and Iowa Professional Teaching Practices Commission; and led numerous Board of Regents task forces and committees, including serving as chair of the Iowa State University Presidential Search Committee in 1985.

He was a member of several academic and educational honor societies, including Phi Kappa Phi, and he received Phi Kappa Phi's Outstanding Educator Award.

His community service included service on the Mary Greeley Medical Center and Ames Public Library Boards of Directors. He was a member and past president of the Ames Kiwanis Club, and he was a lay teacher for adult Bible study classes for the First Baptist Church of Ames much of his more than 50-year affiliation with the church. He had many interests, including golf, and the study of American and Biblical history. Dr. Lagomarcino led an active retirement, authoring three books: *A Window on Main Street*, about growing up in Waverly, Iowa; *The Owl, the Elephant and the Other Side of the Mountain*, a reflection on his years in education and at Iowa State University; and a children's book *Life With Santa and Sarah Claus*, a collection of Christmas stories he told his children when they were growing up.

Survivors include his wife, Neva Dorothy, children: Mary (John) Anderson, Ames; Mark (Teresa) of West Des Moines; and Martha (Tom) Gleason, Boone; grandchildren Scott (Gretchen) and Michele Anderson of Ames, and Justin, Jared and Sarah of West Des Moines; and great grandchildren Tyler and Lucas Anderson of Ames. He was preceded in death by his parents.

A memorial service will be held at 3 p.m. Friday, July 24, at the First Baptist Church, 200 Lynn Avenue, Ames, Iowa, with the Rev. David Russell officiating. Private burial will be at the Ames Municipal Cemetery. Adams Funeral Home of Ames is in charge of arrangements. The family requests that memorials be designated to the Virgil and Dorothy Lagomarcino Scholarship Fund in care of the Iowa State University Foundation.
