Alumni support of the Chapter sets new Records!

As we near the 100th anniversary of the founding of the chapter, the alumni of the Iowa State chapter have been more than generous with their support of the actions of the Board and the Chapter. Make no mistake about it, the support of the alumni have been crucial to the success that the chapter has enjoyed, and we cannot thank you enough for all that you have done over these past few years. One of the primary stories of this issue of the newsletter is to thank and inform all of our alumni about what has been accomplished, and how your funds have been used in support of the chapter.

The major project this past year was the creation of a library on the third floor of the chapter house. As you know, this project was completed this past fall, and has become one of the most heavily used (and appreciated!) rooms in the chapter house. The room was originally the idea of the men of the chapter, and Brother **Nicholas Seibold #1032** drew up the initial plans and layout of the room. Construction started in May, 2008 and was completed in November to the rave reviews of everyone who has seen the new room.

When all of the work was completed, the total cost of the room and its furnishings came to a total of \$40,216.52 with our alumni contributing \$28,195 towards this amount. The remaining balance of \$12,021.52 was transferred from the funds

available in the Drdla Account that we have invested with the Acacia Fraternity Foundation. The room will be officially dedicated at 2:00 pm on Saturday afternoon, March 14th as a part of our centennial celebration. The room will be named in the honor of all of our alumni who have donated \$5,000 or more towards the cost of the creation of the library.

The pictures that we have taken and reproduced in the newsletter do not do justice to the room itself. I trust that all who attend will take the time to visit the 3rd floor and look around. The north room on the 3rd floor now has its own private bathroom, there is a kitchenette available for use for all of the members who are working in the library, and the Drdla Presidential Suite is truly a magnificent room, complete with a small kitchen, living room, bedroom, and outside patio deck. It is a far cry from the cold air dorm that once existed and many of us used when we lived in the house!

The history book has been completed and is at the publisher being printed as this newsletter is being sent out. It is impossible to calculate how many hours Brothers **George Gross #343**, **Jeremy Davis #969** and **Harold Zarr #814** spent in writing and editing this book, but we feel confident that everyone who gets a copy will be very pleased with the final result. The book ended up being approximately 330 pages in length, and covers the history of the chapter from the date of its inception up until the centennial celebration.

We would be remiss with mentioning a few of the most significant contributors to the book. One of these men is **Brother Lee R. Christensen #601**, who contributed a considerable amount of information concerning the 1960's for the writing of this book. Brother Christensen had maintained in his personal archives for all these years, and he graciously loaned them for the writing of this book.

They were an absolutely invaluable resource in compiling a record of the achievements of the 1960's, and the authors are indebted to him for this material.

A second alumnus of note is **Brother Mark R. Bortle #821**. Mark's father, **Robert I. Bortle #396** had maintained a number of records from the time during which he served on the Corporate Board, and this information was critical in serving as the launching point for the history of the properties owned by the Board, and in particular, the "This Is It Fund." These records spanned the time frame from the mid-1950's up until the late 1960's, and provided us with crucial insight into how this program was initiated, its goals and the ultimate end result of the campaign to build a new chapter house. The records were crucial in helping us to find all of the records on the properties owned by the Board. This section, some 50 pages in length, provides the most comprehensive and detailed set of records on the properties owned by the Board that has ever been compiled.

A third alumnus who must be mentioned is **Brother Alan D. Hoffman #915** who supplied us with numerous photo's and stories from the 1980's. His contribution significantly helped us to piece together much of the events of the 1980's, including those which ultimately lead up to the closing of the chapter in the early 1990's.

The records maintained by Board President **Harold Zarr #814** provided a very detailed record of all of the events that transpired from the mid-1990's until the present time as the chapter was being recolonized and being put back on its feet. He maintained copies of virtually all correspondence, financial records, and legal transactions which provided a complete and comprehensive look at the efforts which were required to return the chapter to the Iowa State Greek System.

Finally, we would be remiss if we did not recognize the contribution of two of our Acacia Little Sisters, **Mary Ann (Vorisek) Dilla** and **Cindy (Buch) Kail**. Cindy graciously took the time to share pictures that she had from the days when she was initiated and a member of the little sister organization. She also provided us with a very detailed accounting of many of the events in which she participated during that time. It is a fascinating read, and I'm sure that all will enjoy the stories and pictures that she provided. Mary Ann provided us with the details of how the organization began, and the roll that she played in that event. While I could relate the story here, I won't -- if you want to find out how this organization got its start -- you are going to have buy a copy of the book!

It is also important to thanks the tens of alumni and other little sisters who took time out of their busy schedules to provide material and/or "proofread" specific chapters of the book that related to the years during which they lived in the house. While I cannot mention them all by name (as I'm certain I would forget someone), you should know that their contributions to this project were just as vital as that of anyone else. It was the combined effort of dozens of alumni who have each contributed, in both small and large ways; to the writing of book that we are convinced will be enjoyed by all of the alumni of the chapter.

Hard bound copies are available at a cost of \$50 each. Soft bound copies are available at \$25 each. **Each alumnus who attends the centennial will get one softbound copy of the book for free.** An order form is included with this newsletter. Since there are only a limited number of both hard and softbound copies available, you might want to order one right away to ensure that you get your own copy! **Also, please note that the purchase of book is 100% tax-deductible to you as the funds are deposited in the scholarship account of the chapter with the Acacia Fraternity Foundation.**

Capital improvement projects in the chapter house were not neglected in 2008. The money contributed in 2007 and 2008 was put to good use in July, 2008 with the installation of twenty windows in the chapter house with new, energy efficient Anderson® windows. With the installation of these windows, virtually all of the windows in the chapter house have now been replaced with new windows. The difference that the installation of these windows has made in the living conditions of the chapter house is phenomenal. The drafts and air leakage in the house have been virtually eliminated, and the environment is much more comfortable and conducive for studying than it was in the past.

The second major project that these funds were used for was the conversion of north room on the third floor to one having a private bathroom. The funds raised for the construction for the library could not be used for this project, as it was not for the "library" itself. But this conversation has made this room into one of the "premier" rooms in the chapter house, second only to perhaps the presidential suite itself.

Our gratitude to the alumni for donations for these projects is profound. Donations for these kinds of projects are NOT tax-deductible, and without the support of our alumni, it is doubtful that the Board could have afforded to make these improvements so quickly on its own. We can not thank all of the alumni enough for their support for these kinds of projects, and we want you to know how important it is, and how grateful we are, to those of you who are willing to support projects like these!

When the chapter was refounded, academic excellence was perhaps the most critical attribute that we looked for when recruiting new members and it became the foundation around which we built the chapter. Over the years, the Board and the Chapter have worked to strengthen the support provided to all of the members to help them in their academic studies and in helping them to pay the costs associated with attending school at Iowa State University.

Initially, the Board provided a \$100 scholarship to each member who earned a 3.00 or above grade point in a semester. However, in 2005 this program was expanded to include scholarships in three different categories. One area is in chapter leadership. Members who excel in providing leadership to the chapter may be awarded a scholarship in an amount to be determined by the Corporate Board. A second scholarship is awarded to each member who lives in the chapter house. Each member who lives in the chapter house is awarded \$225 per semester to help defray the cost of living in the chapter house. The third scholarship is based on academic performance. Every member who earns a 3.00 or above receives a \$200 scholarship. Over the years, literally thousands of dollars have been awarded in scholarships to members of the chapter. The amounts awarded for scholarships for some of the recent years include \$18,657 in 2006; \$36,117 in 2007; and \$26,207 in 2008.

Our ability to award scholarships is a direct result of the generosity of our alumni. The funds donated are directly used to support the active chapter members in their pursuit of their academic degree's, and we cannot thank our alumni enough for the generosity that they have shown to the members of the chapter over the years.

Friday – March 13, 2009

Greetings my Brother ACACIANS!

Well, the planning is done, the events are set, and all we have to do is wait for the centennial event to start.

As I mentioned earlier in the newsletter, you will want to double-check the list of people that I have for each event. If you plan to attend an event, you will need to make your reservation right away. We have to submit the count for the number of people that will be attending both the Friday and Saturday evening events on Monday, February 23rd, so if you plan to attend you will need to send in your reservation right away. **If we do not receive your reservation form and payment by Monday, February 23rd, you will not be able to attend either of these two events.**

Included with this newsletter is the official ballot for the Board elections for this spring. Gene Lucht, who has served for these past four years as Board Secretary will be stepping down this spring. He has served with distinction in this position, and we cannot thank him enough for all that he has done on the Board. Phil Sherman is running for his position, and we are excited that he has stepped forward and volunteered to work with us on the Board.

I do want to share with everyone some information that we have learned during the past few months regarding scholarship donations. In September, one of our alumni donated funds to one of the scholarship account that we maintain through the ISU Foundation. I was later contacted by this alumnus to make certain that the funds were properly deposited in our account.

I checked on the deposit and confirmed that it had been made, but I did tell this alumnus that the ISU Foundation now charges a 5% deposit fee on any donation made to the ISU Foundation. Basically, the ISU Foundation takes for itself 5% of the dollar amount that any person donates to any fund controlled by the ISU Foundation and then deposits the remaining 95% in the appropriate account. The ISU Foundation has not made it widely known that it does this, however.

Once the Acacia alumnus found out about this, he demanded his money back (which he eventually got after the ISU Foundation tried to talk him out of getting it back) and deposited in our account with the Acacia Fraternity Foundation.

I am sharing this information with you so that you will know how the ISU Foundation handles donations at this time. I am NOT telling you not to donate money to the ISU Foundation. That is entirely up to you. But just realize that the ISU Foundation will skim 5% off-the-top for itself when you do make a donation.

Preliminary grade results for the fall semester indicate a grade point average of 3.21 for the chapter, which should put us in the top three chapters in the ISU Greek System. Time will tell if we retain the #1 spot. This will be addressed in the next newsletter.

My thanks to all who have supported the chapter over the past year. Your support is vital to our success, and I want you to know that I am deeply appreciative of your good wishes and financial support. Best wishes to each of you for 2009!
